ORDER:-

During the Budget session 2025-26, the Hon'ble Minister for Higher Education has made the following Announcement on the floor of the Legislative Assembly:-

“ஆசிரியர்கள் மற்றும் மாணாக்கர்களுக்கு தொழில்துறை வெளிப்பாட்டை வழங்குவதற்கும், நிறுவனத்தில் தொழில் கலாச்சாரத்தை வழங்குவதற்கும், மாணாக்கர்களின் வேலைவாய்ப்புத் திறனை மேம்படுத்துவதற்கும், தொழில்-கல்வி ஒத்துழைப்பை மேம்படுத்துவதற்கும், தொழில்துறை தேவைகளுக்கு ஏற்ப திறன் மேம்பாட்டை ஊக்குவிப்பதற்கும், தமிழ்நாட்டில் உள்ள 54 அரசு பலவகை தொழில்நுட்பக் கல்லூரிகளில், கல்வி நிறுவன மற்றும் தொழில் நிறுவன இடைமுகப் பிரிவு (Industry Institution Interface Cell) தலா ரூ.2 இலட்சம் வீதம், மொத்தம் ரூ.1.08 கோடி மதிப்பீட்டில் நிறுவப்படும்”.

2. Based on the above announcement, the Commissioner of Technical Education, Chennai has sent the proposal for the establishment of the Industry Institution Interface Cell(IIIC) in 54 Government Polytechnic Colleges and stated that the Industry Institution Interface Cell (IIIC), to be registered as a society, shall be formed to bridge this gap through structured academia – industry collaboration. The Chairman will be a representative from leading industries, selected transparently through and Expression of Interest (Eoi) process, ensuring active industry leadership and also submitted the following details:-

i. Objectives

- Upgrade Laboratories / Workshops: Industry-funded infrastructure for hands-on training.
- Certification Programs: Develop industry-recognized courses (e.g., CAD/CAM, IoT).
- Mandatory Internships: 6–12 months for final-year students.
- Curriculum Revamp: Regular updates based on industry feedback.
- Faculty Development: Industry immersion and training programs.
- Employability: Soft skills, entrepreneurship, and placement drives.

ii. Core Activities of the Industry-Institution Interface Cell

- Industry Partnerships: MoUs for laboratory modernization, guest lectures, joint projects, and funding through CSR activities.
- Curriculum Alignment: Industry-aligned modules.
- Internships & Live Projects: Solve real-world industry problems.
- Workshops/Seminars: Industry conclaves, technical training.
- Industrial Visits: Structured exposure to industry practices.
- Placement Support: Job fairs, pre-placement training and employer feedback.
- Core activities are not limited to the above; IIIC may undertake additional initiatives fulfilling its objectives with prior permission from the Commissioner of Technical Education.

iv. Financial Commitment to the Government

The Non-Recurring Cost of ₹1.08 crore (₹2 lakhs/college for 54 colleges) for IIIC is required towards the seed money. The IIIC will find out the means to generate funds to make the institution self-sustainable.

Recurring costs are covered via existing funds available from institutions, industry collaborations, and revenue from consultancy projects.

v. Sustainability and Legal Framework:

- Registered Society: IIIC will operate as a legal entity to ensure accountability and long-term viability.
- Sustainable Model: Collaborative governance involving institutions, industries, and IIIC members.
- Renew MoUs with MSMEs, CII, and large Industries; leverage CSR funds for infrastructure.
- Faculty internships, alumni networks, and revenue from skill certifications/consultancy.

vi. Steering committee

The Steering Committee in the Industry-Institution Interface Cell (IIIC) plays a crucial role in guiding and overseeing the operations, strategy and overall functioning of the IIIC. Internship Participation, Placement rates, Certifications and Industry feedback are the key performance indicators. The committee will review the progress once a year. Hence, it has been requested the Government to form the State Level Steering Committee with the following Members:-

vii. Appointment of IIIC Chairman and Members:

The IIIC consists of 8 members, one HoD or Senior faculty, representative from Industrial Associations, Placement officer of the Institution, one alumni, one students representative, besides the Principal of the Polytechnic College as Member-Secretary. One of the industrial representatives is the Chairman of the Committee selected through Expression of Interest (Eoi). As IIIC has to be constituted in 54 Government Polytechnic Colleges, constitution in all polytechnic colleges itself involves a lot of paper work and even after its constitution, there

may a possibility to occur changes now and then in respect of members of the Committee. The Chairman or a member of the Committee may opt for relinquishing the position or sometimes, the administration may have to bring changes with better performing members. In that event, it may not be possible to get orders from the Government then and there; Hence, the Commissioner of Technical Education has therefore requested the Government for constitution of the Committee at their level.

3. The Commissioner of Technical Education has therefore requested the Government to issue orders on the following:-

- a) To accord administrative and financial sanction towards non-recurring expenditures for setting up IIIC in 54 government polytechnic colleges to a sum of Rs.1.08 crore for seed funding by creating a new head of account.
- b) To authorize the Director of Technical Education to draw and disburse the sanctioned amount in one lump sum.
- c) To approve the formation of the Establishment of Industry Institution Interface Cell (IIIC) as a registered society in Government Polytechnic Colleges across Tamil Nadu.
- d) To permit the Commissioner of Technical Education to form/modify IIIC committees in 54 Government Polytechnic Colleges and implement the Eol process for Chairman selection.
- e) To issue orders to form the State Level Steering Committee consisting of the Member mentioned above.

4. The Government after careful examination of the proposal of Commissioner of Technical Education decided to accept the same and accordingly issue orders as follows:-

- i) Administrative and financial sanction for a sum of Rs.1,08,00,000/- (Rupees One crore and eight lakh only) is accorded towards non-recurring expenditures for setting up of Industry Institution Interface Cell (IIIC) in Rs.2,00,000/- for 54 Government polytechnic Colleges.
- ii) The Commissioner of Technical Education is authorised to draw and disburse the sanctioned amount in one lump sum.
- iii) The approval for formation of the Establishment of Industry Institution Interface Cell (IIIC) is accorded as a registered society in Government Polytechnic Colleges across Tamil Nadu.
- iv) The Commissioner of Technical Education is permitted to form/modify IIIC committees in 54 Government Polytechnic Colleges and implement the Expression of Interest (Eol) process for Chairman selection.

5. The Government has Constituted the State Level Steering Committee consisting of the following Members to oversee the operations, strategy and overall functioning of the Industry Institution Interface Cell (IIIC) and review the progress once a year:-

6. The expenditure sanctioned in para – 4 above shall be debited under following Head of Account:-

2203-00-Technical Education – 001 – Direction and Administration –
States Expenditure – AA – Directorate of Technical Education – 309 –
Grants in Aid- 03 – Grants for Specific Schemes.

(DPC:2203 00 001 AA 309 03)

7. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates for the year 2025-2026. Pending approval of the Legislature, the expenditure may be initially met by drawl of an advance from the Contingency Fund. The Commissioner of Technical Education is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form "A" appended to the Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued form Finance (BG.I) Department. The Commissioner of Technical Education shall also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2025-2026 to Government in Finance (Education I / BG-I) Department at an appropriate time without fail.
